knowledge: legal concepts; state-legal and constitutional development of Kazakhstan at historical stages; features of the functioning of the legal system and state mechanism of the Republic of Kazakhstan; constitutional structure of the Republic of Kazakhstan; content of normative legal acts and theoretical approaches defining a specific area of its activity, to understand their significance for the realization of the right in professional activity; forms and mechanisms of protection of rights citizens and legal entities; the essence, nature and interaction of legal and state phenomena; the interrelation of legal disciplines in an integral system of knowledge and the importance for the realization of law in professional activity; the essence, types and forms of the state; the concept and essence of law; justice and its principles; psychological features and specifics of business communication, elements of professional ethics in the work of a lawyer; the structure of state power and management, the organization of legal protection of individuals and legal entities persons; basic rules for the preparation of legal documents; features of preventive work on offenses; methods of legal propaganda and legal education, the essence and social role of their profession.

ability: to creatively apply the acquired knowledge in practice, be able to translate new knowledge into concrete proposals; independently improve their qualifications, replenish knowledge and acquire new skills and abilities; receive and process the necessary information, critically analyze it and make conclusions and generalizations; find optimal ways to solve problems and make decisions related to the implementation of tasks in professional activity; freely operate with legal concepts and categories; analyze the current situation and see the prospects for its further development; to anticipate possible consequences according to the available data; to orient oneself in the system, structure, competence of state, including law enforcement agencies; to interpret the norms of various branches of law; to use normative legal acts in professional activity; to understand the introduced legislative innovations; to express and justify one's point of view logically competently; to use computer and other innovative technologies; to carry out competent document management; compile various legal documents; analyze and solve legal problems in the field of civil law, labor, administrative law, criminal law and other relations; analyze and prepare proposals for improving the legal activities of organizations (enterprises), provide legal assistance to individuals and legal entities, manage their emotional state, as well as have a good operational memory, developed verbally-logical and analytical thinking, tolerance, responsibility and organization;

have the skills to: use the acquired knowledge and methods of the humanities and socio-economic sciences in professional activity; research work; analysis of legal norms and legal relations included in the field of professional activity; work on a computer, search, collection and analysis of legal and other information necessary for professional activity, including in search engines and the Internet; development and compilation of legal documents, preparation of reasonable information at the request of legal entities and individuals; logical analysis of problematic situations, assimilation and memorization of the entire range of circumstances and details related to the area of work performed, establishing and maintaining relationships with colleagues; establishing and developing interpersonal relationships taking into account the implementation of professional duties, interviewing and consulting on legal issues; conducting interrogation and speaking in court debates; using alternative methods of dispute resolution and legal techniques; search for opportunities to improve regulatory documents and the mechanism of implementation of legal decisions; comparative analysis; be competent in: the application of legal norms and theories in specific practical situations; legal technique, the ability to identify implicit assumptions, to see errors and omissions in the logic of reasoning; to distinguish between facts and consequences; assessing the significance of arguments and facts; developing plans and a possible system of actions; using knowledge from different industries to draw up a plan for solving legal problems; investigation of all the circumstances of the legal case and making an informed decision; the use of professionally-oriented information technologies in the legal field, as well as databases and legal information processing processes; independent work with information, preparation of conclusions and recommendations on organizational and legal issues, regulations; preparation of necessary procedural documents; issues of record keeping; in psychological techniques of interviewing and interrogation; evaluation of the advantages and disadvantages of proposals on amendments to regulatory documents; joint activities in a team, working groups, interaction with experts in other subject areas; evaluation of the results of their activities.

- the ability to understand the meaning of culture as a form of human existence and to be guided in their activities by basic cultural values, modern principles of tolerance, dialogue and cooperation;
